CCA requires that in order to be recertified as a Colorado Certified Death Investigator at least 64 hours of continuing education in each four-year certification period is documented.

Each activity must be documented. Documentation should be sent to CCA three-months prior to expiration.

Approved Continuing Education Activities include courses accredited by: CCA, ABMDI, American Medical Association, American Nursing Association, American Bar Association, Peace Officer Standards Training (or equivalent) and Post secondary institutions recognized by national educational accrediting agencies (Accredited College or University).

List Activities on Folder – Save Documentation Inside

Sixty-four hours of continuing education are required within a four-year period for recertification. Continuing Education hours may only be accumulated AFTER certification date. Hours should be listed on the lines provided and documentation should be saved inside this folder.
