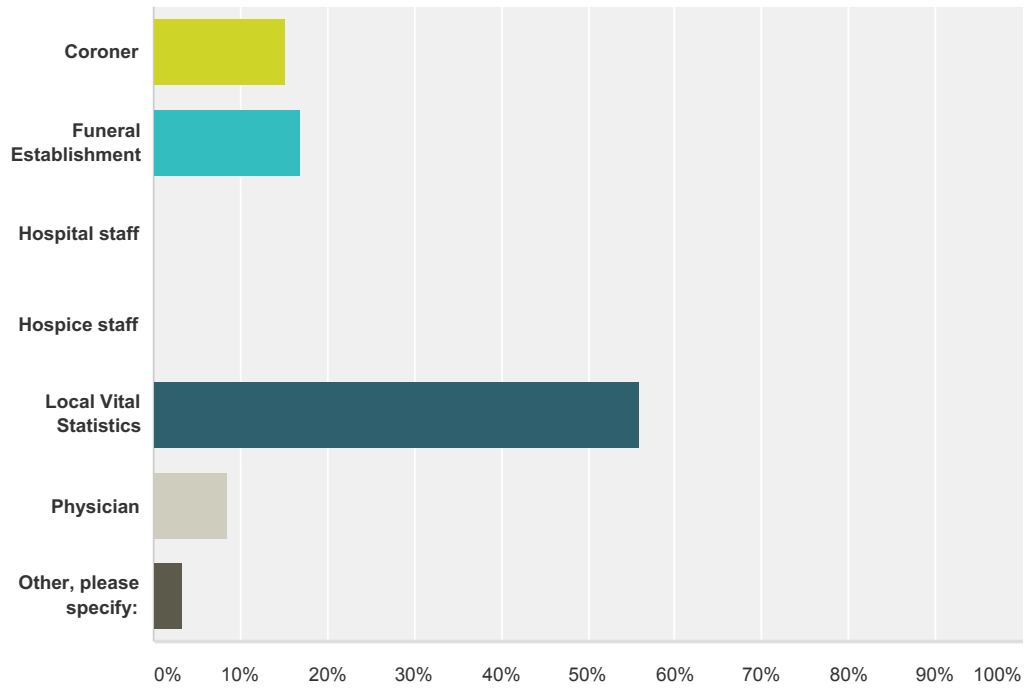

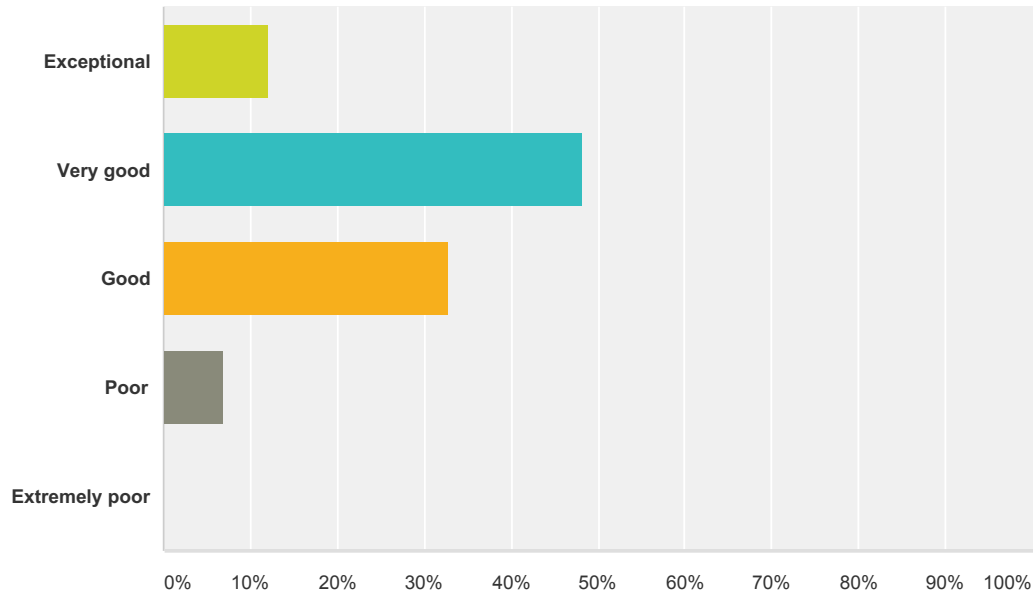

### Q4 Overall, how would you rate the EDR?

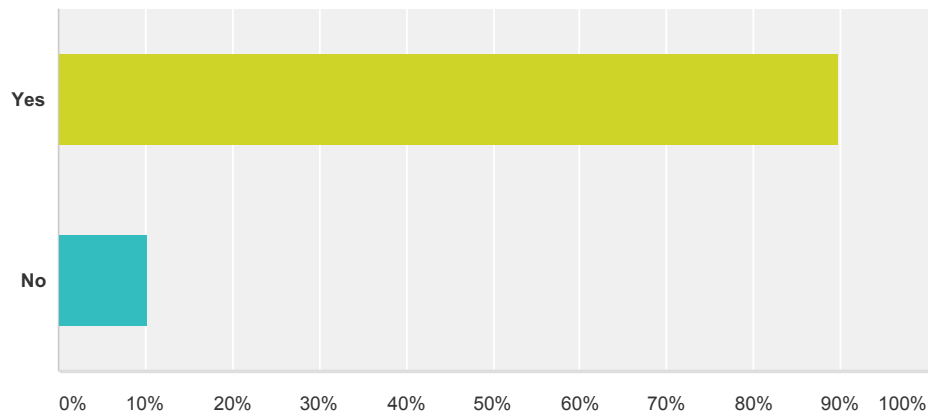

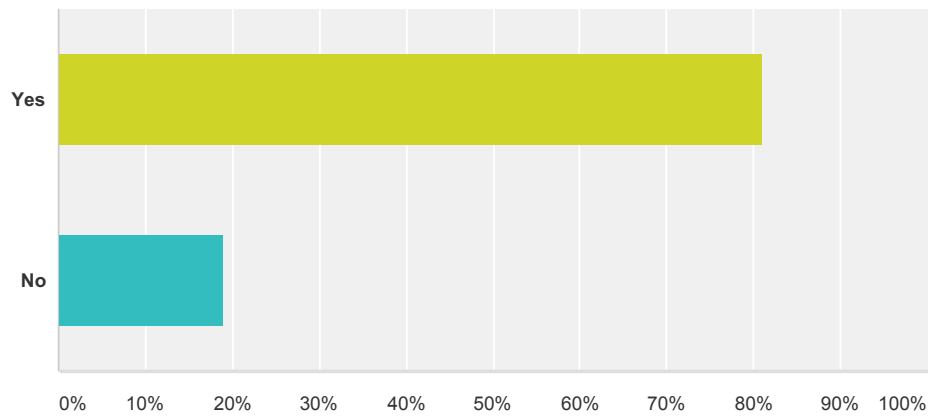

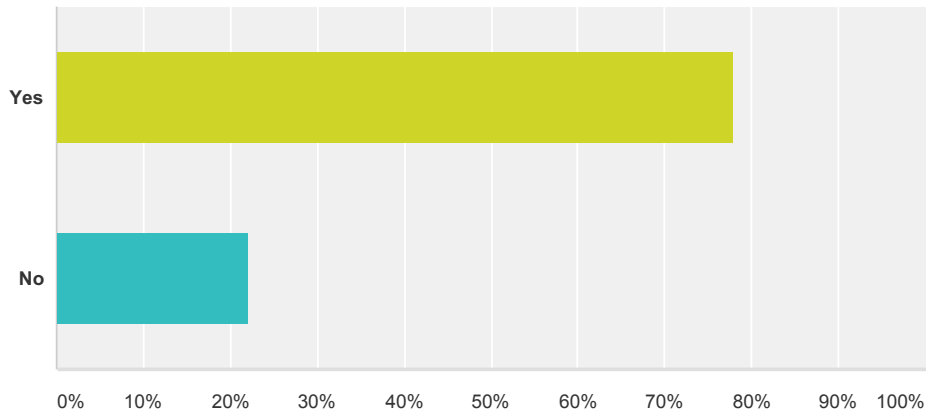

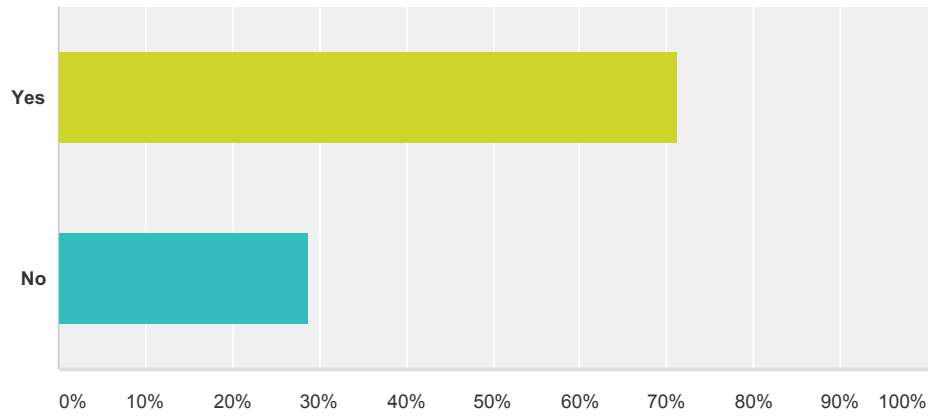

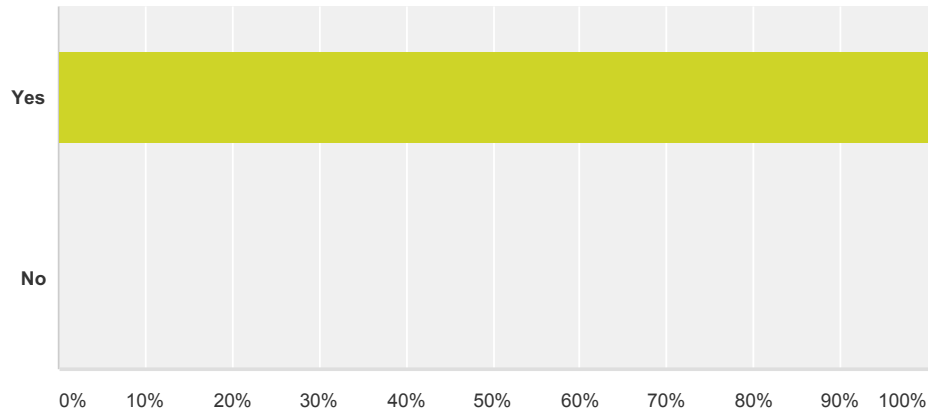

**Q9 Do you receive timely responses when you contact the Field Unit (Pete, Renee, Michelle) with EDR questions or technical problems?**

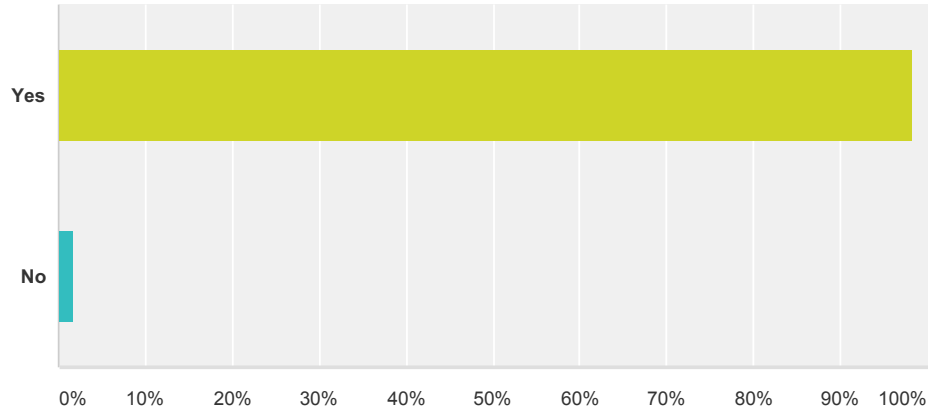

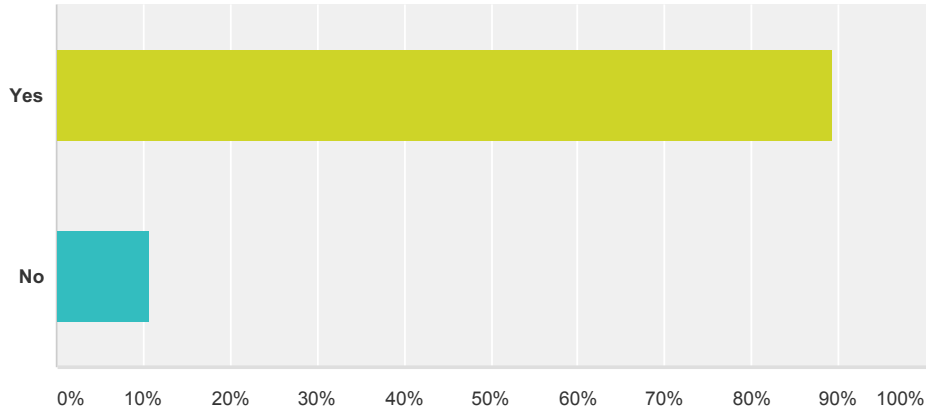

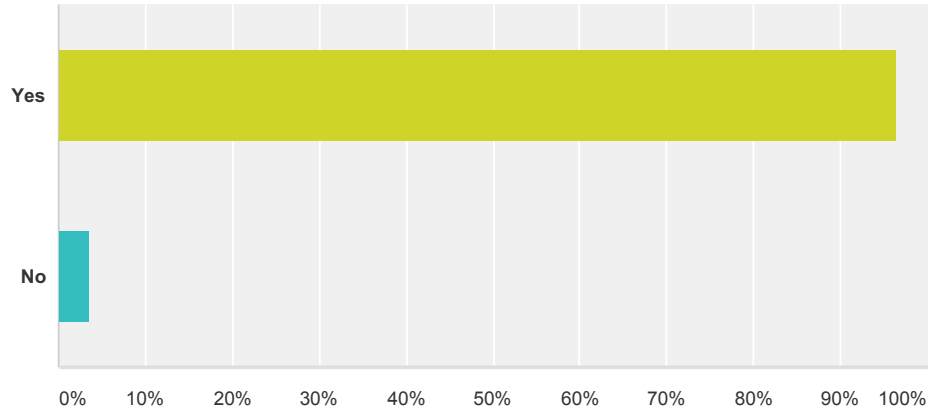

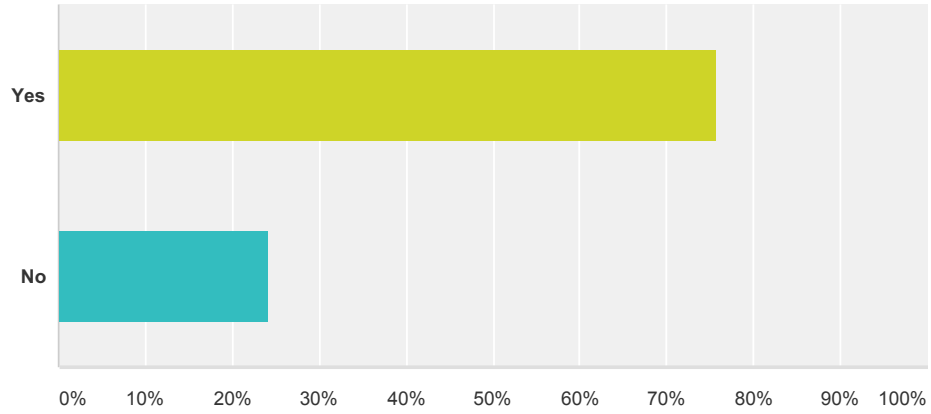

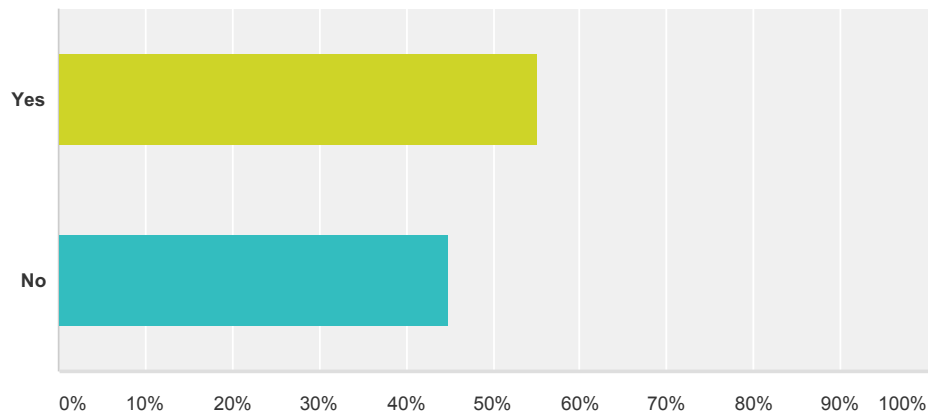

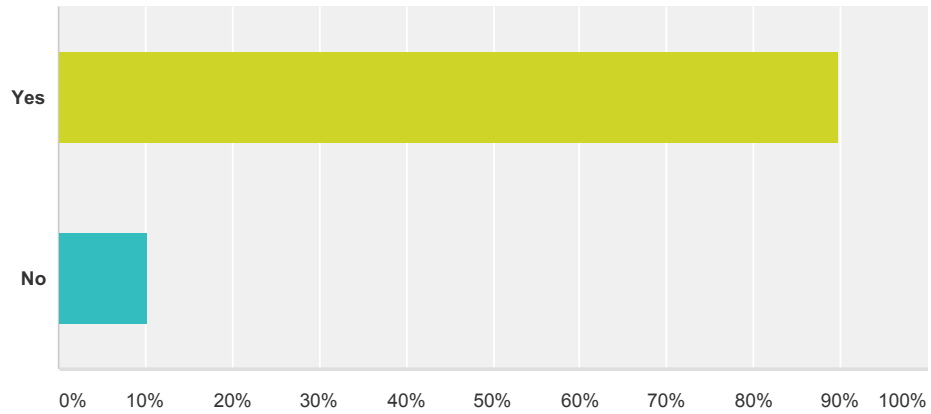
