The Board will consider all eligible applicants and make a decision at the 10/03/2011 Board Meeting.

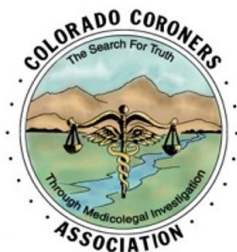
If you have always been one those who are critical about CCA, you have no excuse to miss this opportunity to become involved.

Committee Reports

Education Committee

The Education Committee duties are to develop programs for the Outreach Seminars, June Conference and any other education programs offered by CCA. The Chair is Chris Herndon.

The next MLDI class will be in Grand Junction on October 3 -5, 2011. This is a great basic death investigation class, we hope to have about 40 people in attendance.

Legislation Committee

The Legislative Committee duties are to monitor legislation during the legislative session, develop legislation when needed, seek Coroner opinion on legislation, work with the CCA lobbyist on legislative strategy, and organize testimony on legislation when needed. Pat Allen, MD, Larimer County (CCA President) is the chair.

On Friday August 26, Dr. Allen and our lobbyist, Peg Ackerman, attended the Metro Area County Commissioners (MACC) meeting in Brighton. This meeting is the annual meeting for state organizations such as the CCA, the County Sheriffs, Clerks and Records, etc. to present upcoming legislative issues to the collective Metro commissioners so that they are informed of any proposed legislation coming in the next legislative session and can decide to support issues that they deem important.

Dr. Allen presented the CCA agenda for the upcoming session. Namely, revising the Colorado statutes as regards the Coroners of the state. This new legislation would consolidate all references to Coroners in one place, making the laws easier to access; would update/modernize statutes to make them applicable to 2012; would be more specific regarding what a coroner can and cannot do in the performance of duties. Note that this last part- the performance of duties part- is exactly what we proposed initiating in the annual meeting in

Blackhawk in June. It will eventually result in statewide standards for all Coroners and will also address the concerns of the CCSTB regarding the "Standards" part of their mission. The CCA hopes to get support from both the County Sheriffs of Colorado and the Colorado District Attorneys Council on this bill.

Coroner Assist Team

The Coroner Assist Team coordinates requests for assistance and referrals from any Colorado County Coroner. The team maintains a list of available equipment, qualified personnel, and forensic specialists. The Coroner Assist Team is Co-Chaired by Darrel Brenner, Washington County and Steve Stogsdill, Mesa County.

CCA Representatives to other Committees

Drug Abuse that is Legal

Designer Drugs- Focus on "Spice"

Recently our office has had a death associated with the use of the designer drug known as "Spice", also known by many other names, including K2, Space, Pot-pourri, Genie, Buzz, Mr. Smiley, and many others. This product is a blend of synthetic cannabinoids and is legally sold in many places such as gas stations, truck stops along the Interstate system, smoke/head shops, etc. I have seen it at the counters of a number of gas stations in the region, including neighboring states. They are sold as incense or as herbal smoking blends. A growing number of emergency room visits due to adverse reactions and deaths have been associated with its use. Many countries have banned its sale as well as some but not all states in the USA. Colorado coroners need to be aware of this drug and its potential to be associated with sudden death.

I have attached a number of recent references and articles for your files. Some of the national

laboratories can now test for this complex of synthetic cannabinoids.

this point, but keep in mind that we will be asking for 2011 most likely early next year.

Guest Articles

The Colorado Department of Transportation's Fatality Analysis Reporting System (FARS) has been working with all Colorado Coroners to receive BAC and Drug data for people involved in traffic-related fatalities throughout the State of Colorado. I represent the CDOT's FARS Program and with the help of my FARS's Analysts, Kevin Dietrick and Charles Keep. The information collected from the Coroners gets reported to the National Center for Statistics and Analysis (NCSA) of the National Highway Traffic Safety Administration (NHTSA). Presently, every County Coroner is contacted twice each year for BAC and drug data and for the most part, the County Coroner Offices cooperate with us.

All data pertaining to auto-related fatalities are housed and kept confidential at CDOT, but as part of our multi-year Cooperative Agreement with NHTSA, the data received is disseminated through the FARS System.

This critical data is analyzed by the NCSA to prepare Reports for Congress who have the authorization to allocate funds for State Counties needing assistance in DUI enforcement. Certainly, for the Counties that cooperate with the Colorado FARS program, there is a great benefit not only in reducing the fatalities, but also in possible financial incentives.

The attached spreadsheet shows the status of the 2010 BAC collection from all Colorado Coroners as of today. Please note, the ones with the blank "status" have not responded to us and that we can only assume their name and contact is accurate, at least that is what we show in our system. The 2010 FARS dataset officially closes on December 30th 2011, therefore we only have a few months to collect the data. The 2010 is our major focus at

Angel Eyes is a resource for coroners throughout Colorado when they have a case of a death of an infant or toddler in a sudden, unexpected and, perhaps, an undetermined fashion. Angel Eyes, formerly The Colorado SIDS Program, is the only organization in Colorado that provides bereavement and support services to support SUID families. Although the determination of the final cause of death, at times, is now SUID, SUIDI or Undetermined, the grief of these families is the similar. Coroners have initial contact with these parents – a contact that these families always remember. They appreciate the sensitivity with which you treat them – as do we. Your respect for their child and for their loss lays a foundation for them to begin to come to grips with what has happened to their family.

We provide a next step for these families. We contact them as soon as we hear from you. We reach out to them, let them know that we exist, tell them what services are available for them, and listen to what they might need. Our initial contact, information and literature provide some structure for them as they try to navigate their way through a bewildering experience. Our social worker is also available to answer any initial questions they have and/or to personally meet with them at their home or our office. As families have said, "we never knew we'd have to figure out how to bury our child".

We also provide on-going services for these families. As we check in with them over time, we are able to inquire if they need additional services such as local support groups or mental health interventions. We have an extensive referral base throughout the state for bereavement groups, individuals and mental health centers that are available for them. We hold monthly support groups both in Denver and in Colorado Springs, offer peer contacts, an annual Memorial Walk and continuing support as they walk through this unexpected and difficult period of their lives.

Contact us to report a death by calling us at 303-320-7771. Some coroners prefer to fax us the basic case information including D.O.B, D.O.D., family contact information and a basic narrative about the circumstances of the death.
