## Guest Articles

### **Foxy Methoxy; A new designer drug to consider:**

Foxy Methoxy is one of many slang terms for 5-methoxy-N,N-diisopropyltryptamine (5-MeO-DIPT) and is a hallucinogenic club drug in the tryptamine family, similar in effect to psilocybin. It is available as a powder, liquid or more commonly a red or purple pressed tablet, often with an embossed alien head or spider. There are also capsules that tend to have either a blue, green, tan, orange, gray or pink powder.

Ingestion is the most common method, followed by snorting or smoking. Effects are dose-dependent and occur within 20-30 minutes, peaking at 60-90 minutes and last for up to 6 hours. Effects include hallucinations, euphoria, empathy, visual and auditory disturbances or distortions, emotional distress, dilated pupils, talkativeness, disinhibition, nausea, vomiting, diarrhea, muscle tension, jaw clenching, etc.

Other slang terms include fox, foxy, foxys, trash, dip foxy, roxy, yum yum, muffy, excite-bike and five.

This drug has been in use in the Metro Denver area and may be one more designer drug to consider when working up those difficult toxicology cases. At least one of the national toxicology laboratories can test for this compound.
