Legislation Committee

The Legislative Committee duties are to monitor legislation during the legislative session, develop legislation when needed, seek Coroner opinion on legislation, work with the CCA lobbyist on legislative strategy, and organize testimony on legislation when needed. Sharon Morris, Park County is the chair.

There has not been any legislation directly involving Coroners this year. Our lobbyist, Peg Ackerman, has been diligent with keeping aware of legislation. Two bills involve us in only a peripheral sense. Those two are one bill allowing the military to assume custody and provide disposition for unclaimed military deceased. Another is a bill that defines certification for persons involved in the funeral preparation industry. The first bill has passed and awaits signing by the Governor. The other is working its way through the system.

Coroner Assist Team

The Coroner Assist Team coordinates requests for assistance and referrals from any Colorado County Coroner. The team maintains a list of available equipment, qualified personnel, and forensic specialists. The Coroner Assist Team is Co-Chaired by Darell Brenner, Washington County and Steve Stogsdill, Mesa County.

The team is working on re-vamping everything from the ground up. Every coroner will be receiving a request for information about what kind of supplies you have and how many people you would be able to supply if needed. When you get the form please fill it out and get it back to the team, it will help them get organized.

Certification Committee

The Certification Committee is responsible for keeping the records of Certified Death Investigators, including new applicants and continuing education. Brenda Bock, Grand County is the Chair.

You can now check the status of certified investigators on our website in the Certification section.

Brenda wants to remind everyone that her address has changed and they need to make sure to send their info to the new address.

CCA Representatives to other Committees

The next cycle for scholarship applications to one of the major death investigation schools will begin in the spring of 2009. The successful applicant will be announced at June conference. We have received one completed application and had requests for a couple of applications, it's time to finish them up and get them in.....

Marketing

Website

CCA has a new webmaster managing coloradocoroners.org. At this time, continue to route items for the website through Sharon Morris. Additionally, queries to the site will continue to be routed through Sharon for disposition to the appropriate person. Hits to the website continue at an average of 180 per week. Queries come from high school students and others wanting to know about employment in the field, from vendors, from other Coroners associations and from the public.

“Green” Burials:

There is more and more momentum to have loved ones buried on personal property and in manners that do not require caskets, vaults, etc. Currently there are no state regulations regarding this practice. I would like to know what experience you have had with these newer practices. Additionally, I need to know if your county has addressed the issue in any way. My environmental health director is of the opinion that regulations regarding the reporting and location of such burials can be added to county land use regulations. Other Coroners have had locations of such burials added to land deeds and others have just specified that they be notified. It appears that some standardization may be needed so please, give me your opinion. smorris@parkco.us If this is not an issue in your county I also want to know that information.
